

## TOTAL CARE LIMITED WARRANTY FOR FLOOR HEATING PRODUCTS INSTALLED BY “CERTIFIED PRO” INSTALLERS

nVent LLC provides a 25 year Total Care Limited Warranty for all products listed below to conform to the specification, when such products are installed by a Certified PRO Installer and connected by a duly licensed and qualified<sup>1</sup> electrician and in accordance with nVent’s installation instructions.

Additionally the online warranty registration form must be completed at [nVent.com/NUHEAT](http://nVent.com/NUHEAT) within thirty (30) days from the date of installation and kept by the owner of the building, together with a copy of the commissioning report, relevant invoice, and photographs showing the product(s) in their entirety after installation but before covering with flooring material. This warranty is non-transferable.

### A TWENTY FIVE (25) YEAR LIMITED PRODUCT WARRANTY FROM THE DATE OF PURCHASE IS AVAILABLE ON THE FOLLOWING PRODUCTS:

### A THREE (3) YEAR LIMITED PRODUCT WARRANTY FROM THE DATE OF PURCHASE IS AVAILABLE ON THE FOLLOWING PRODUCTS:

(“the Products”).

The present Limited Warranty shall be valid for products purchased and installed by a NUHEAT Certified PRO Installer within the United States or Canada on or after November 1st, 2016.

#### If it is suspected that a defect arose in the Product(s) during the Warranty period, nVent:

1. Will examine and confirm that any alleged product issue covered by this Limited Warranty actually exists and occurred in the course of proper and normal use and was not caused by accident, misuse, neglect, alteration or improper installation (including installation by someone other than a NUHEAT Certified PRO Installer), operation, maintenance, repair or testing by an unlicensed or otherwise unqualified electrician or such other cause outside of the responsibility of nVent under this Limited Warranty;



2. Will undertake to repair or replace the Products at nVent's option, at no cost to the Buyer. In order to remedy the defect, nVent must have access to 1m<sup>2</sup> (10 ft<sup>2</sup>) of the floor covering material. nVent reserves the right to determine the appropriate technical solution in order to restore the function of the heating system;
3. Subject to all other terms and conditions of this Limited Warranty, will undertake to restore the floor in its original state or, if not possible, to an equivalent standard, at no cost to the Buyer;
4. Will, in case of thermostats, supply a new thermostat.

<sup>1</sup>"Qualified electrician" means one who has received training in, and has demonstrated skills and knowledge in the construction, operation, and maintenance of electrical equipment, installations, and systems, as well as the hazards involved in them, including the skills and knowledge necessary to recognize and avoid such hazards.

**The Limited Warranty does not apply:**

1. To installations, alterations or repairs that have been carried out by an unlicensed or otherwise unqualified electrician (as defined herein) or to installations performed by someone other than a NUHEAT Certified PRO Installer.
2. To Products subject to misuse, neglect, vandalism, fire, lightning, water damage, alteration, improper installation (including installation by someone other than a NUHEAT Certified PRO Installer), an incorrect floor construction or the use of incorrect materials, or such other act or omission not attributable to nVent.
3. To Products subject to unauthorized modification or alteration—either directly or indirectly—by the installer, the end user, or a third party.
4. To cracks or fractures in tile(s) or grout resulting from structural movement or failure, excessive deflection, or other failure in the flooring substrate.

nVent shall in no case be liable to any party for any loss of profit, loss of business, loss or damage to goodwill, or increased costs or for any indirect, special, punitive or consequential losses or damages, howsoever arising. In the event of the warranty being invoked, contact the nearest nVent office and present the completed Warranty Registration Form, Commissioning Form and purchase invoice. The Buyer may have legal rights under the applicable national legislation governing the sale of consumer goods. Those rights are not affected by the present warranty.
